-Faculty rules

Members are reminded of the following faculty rules in election of faculty board members -12.3 (b) (i) The Fellows, Members and associates who are to be members of the board

- in categories 12.3 (a)(ii) and (iii) shall be elected as follows:
- Nominations may be made prior to, or from the floor of, Annual General Meeting of the
- faculty. The consent of the nominee must be obtained. The Fellows and Members of the
- faculty shall then vote by show of hands for their representatives and the Associates of
- the faculty shall vote by show of hands for their representatives. If a tie for the lastplace
- results in either ballot then a further ballot by show of hands or by secret ballot if
- requested by one of the tied nominees, shall be held between the tied nominees.
- (ii) Fellows and members shall be elected for a term of three years. They may be reelected
- for subsequent terms of three years.
- (iii) Associates shall be elected for a term of one year. They may be re-elected for subsequent terms of one year.) AGM 2014
